

In violation of Title 21, United States Code, Section 846.

COUNT II

On or about January 8, 2009, in the District of Nebraska, ANTONIO FRAUSTO, a/k/a Juan Antonio Frausto-Diaz, a/k/a Antonio F. Ocampo, JOSE RIGOBERTO FRAUSTO-DIAZ, a/k/a Jose Rigoberto, and JORGE ALBERTO HERNANDEZ-CAMPOS, a/k/a Jorge Hernandez-Ocampos, defendants herein, did knowingly and intentionally distribute 50 grams or more of methamphetamine (actual), its salts, isomers, or salts of its isomers, a Schedule II controlled substance.

In violation of Title 21, United States Code, Section 841(a)(1) and Title 21, United States Code, Section 841(b)(1).

COUNT III

On or about January 18, 2009, in the District of Nebraska, ANTONIO FRAUSTO, a/k/a Juan Antonio Frausto-Diaz, a/k/a Antonio F. Ocampo, JOSE RIGOBERTO FRAUSTO-DIAZ, a/k/a Jose Rigoberto, and JORGE ALBERTO HERNANDEZ-CAMPOS, a/k/a Jorge Hernandez-Ocampos, defendants herein, did knowingly and intentionally possess with intent to distribute 500 grams or more of a mixture or substance containing a detectable amount of methamphetamine, its salts, isomers, or salts of its isomers, a Schedule II controlled substance.

In violation of Title 21, United States Code, Section 841(a)(1) and Title 21, United States Code, Section 841(b)(1).

COUNT IV

On or about January 18, 2009, in the District of Nebraska, ANTONIO FRAUSTO, a/k/a Juan Antonio Frausto-Diaz, a/k/a Antonio F. Ocampo, JOSE RIGOBERTO FRAUSTO-DIAZ, a/k/a Jose Rigoberto, and JORGE ALBERTO HERNANDEZ-CAMPOS, a/k/a Jorge Hernandez-Ocampos, defendants herein, did, during and in relation to a drug trafficking crime for which they

could be prosecuted in a Court of the United States, to wit: conspiracy to distribute and possess with intent to distribute methamphetamine, and possession with intent to distribute methamphetamine as set forth in Counts I, II, and III of this Indictment, use and carry, and in furtherance of such drug trafficking crime, possess a firearm, to wit: a CZ 9mm handgun.

In violation of Title 18, United States Code, Section 924(c).

COUNT V

Upon conviction of the offense charged in Count IV set forth herein, any and all interest ANTONIO FRAUSTO, a/k/a Juan Antonio Frausto-Diaz, a/k/a Antonio F. Ocampo, JOSE RIGOBERTO FRAUSTO-DIAZ, a/k/a Jose Rigoberto, and JORGE ALBERTO HERNANDEZ-CAMPOS, a/k/a Jorge Hernandez-Ocampos, defendants herein, has in a CZ 9mm handgun, which had been shipped and transported in interstate and foreign commerce, a firearm involved or used in the knowing commission of the offense alleged in Count IV, is hereby vested in the United States and forfeited to the same.

In violation of Title 18, United State Code, Section 924(d) and Title 28, United States Code, Section 2461(c).

COUNT VI

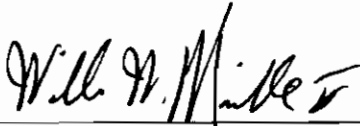
As a result of the forgoing offenses, defendants ANTONIO FRAUSTO, a/k/a Juan Antonio Frausto-Diaz, a/k/a Antonio F. 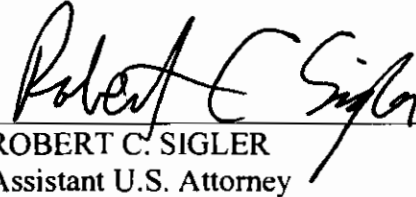
